Terms and Conditions of Child Collection for Kids Club

- All Parents/Caregivers are required to complete a Kid's Club Registration of Interest / Consent Form.
- Children attending MMSS 'The HUB' children's activities are required to meet at the designated meeting point and at the designated meeting time.
Meeting Time: **3.10pm** on the days the program operates
Meeting Place: **Outside Mannum Community College Front Office**
- Children collected will be escorted by MMSS 'The HUB' Worker, Staff member or Volunteer from the collection point to the nominated destination.
Leaving Time: **3.20pm** on the days the program operates
Destination: **MMSS 'The HUB' 58 Walker Ave**
- Any child who is not at the designated meeting point by the designated meeting time, will be deemed and recorded as non-attendance of the program on that day. The non-attending participant will not be the responsibility of MMSS 'The HUB' Worker, Staff member or Volunteer.
- Parents/Caregivers are required to phone MMSS 'The HUB' on **8569 1832** to advise their child will not be attending the program on any particular day so that Workers, staff members and volunteers are not waiting for the participants arrival unnecessarily.
- That Parents/Caregivers/Authorised persons are required to collect their child in person from inside MMSS 'The HUB' and complete the "sign out" section of the attendance sheet.
- That only the nominated Parent/Caregiver/Authorised person can collect and "sign out" the child.
- That children **WILL NOT** be released from the program to a minor or any person who is not authorised to collect the participant.
- That the transportation of any child will not be permitted without the express written permission from the parent/caregiver.
- That Workers, Staff and Volunteers are not permitted to leave MMSS 'The HUB' and walk with any child to deliver them to their home or any other requested location.
